



# BLS (CPR/AED) Certification Course

## Wednesday, April 22, 2026

### Program Description

This evening course will provide a local option for dentists and team members to renew or obtain Basic Life Support Cardiopulmonary Resuscitation (CPR) / Automatic External Defibrillator (AED) certification in a comfortable, friendly environment. Due to a limited number of mannequins and space, **attendance will be restricted to the first 14 registrants.** Attendees will receive 2 hours Continuing Education Credit.

### Learning Objectives

- ◆ Certify attendees with a BLS CPR/AED Certificate — American Heart Association compliant
- ◆ Detailed instructions and demonstration on the operation of the Automated External Defibrillator (AED)
- ◆ Adult/child/infant BLS (CPR/AED)
- ◆ Adult/child/infant choking
- ◆ **Basic first aid review such as allergic reactions, bandaging and bleeding, seizures, etc.**

- ◆ Nick is certified as an American Heart Association instructor
- ◆ A fulltime firefighter & paramedic since 2015 and teaching for Illinois Safety since 2016
